

## Arizona Aloha Festival Raffle 2025 Rules and Regulations

**ELIGIBILITY:** The purchaser of a ticket in the Arizona Aloha Festival Raffle ("Raffle") must be an individual eighteen (18) years or older at time of entry purchase. The purchaser must be present in the state of Arizona at the time of entry purchase and prize collection. It is not necessary to be a resident of the state of Arizona, but one must be physically present in Arizona at the time of entry purchase and prize collection. Only one (1) individual may be identified as an entry purchaser. All federal, state and local laws and regulations apply. Tickets may be purchased from an authorized Board Member, Planning Committee Member, or other authorized seller from February 15, 2025 until the date and time of the drawing as stated below. A hard copy ticket confirmation number is required to claim the prize. Questions concerning ticket confirmation number(s) should be directed to the "Administrator," Arizona Aloha Festivals, Inc., at the address listed below. By entering the Raffle, the entry purchaser acknowledges that he or she is aware of, and agrees to abide by, the Raffle's rules and regulations.

Complete and legible contact information, including full name, address, and telephone number, must be provided to the Administrator by each prize winner. Failure or refusal to do so will disqualify the drawn ticket for the prize award and a new ticket will be drawn to replace the disqualified ticket. This information is required for prize award and tax purposes. Any information provided on the tickets will not be sold or given to any party.

The following individuals are not eligible to participate in the Raffle: (a) Board members of Arizona Aloha Festivals, Inc.; and (b) Planning Committee members of the 2025 Arizona Aloha Festival. The above list of exclusions (items a, b) also applies to immediate family members residing in the same household. Immediate family is defined as spouses, domestic partners, parents, children, spouses of children, and domestic partners of children.

**DRAWINGS:** Tickets will be sold at \$5.00 each. The draw date is March 16, 2025 (the "Draw"). Tickets will be sold until the drawing occurs or until all tickets are sold. The odds of winning are dependent upon the final number of tickets sold. No more than five thousand tickets (5,000) will be printed and sold. The Draw will be conducted at approximately 4:00 pm. In the Raffle, there is no possibility of a tie. The Draw will be conducted under the supervision of the Administrator. All time references are Mountain Standard Time and are approximate.

## TWO PRIZES TO BE AWARDED:

Each air component will be in the form of a Hawaiian Airlines Travel Prize Letter Form ("PRIZE LETTER"), redeemable for 120,000 HawaiianMiles, which is sufficient under current redemption levels to obtain two (2) roundtrip Main Cabin-Coach Class of service tickets from Phoenix to Hawaii. Each PRIZE LETTER will be valid for redemption until at least March 15, 2026 and will be subject to blackout dates and capacity controls. Winners must have or obtain a HawaiianMiles account prior to redemption of the PRIZE LETTER. The PRIZE LETTER will contain the process necessary to redeem the HawaiianMiles. HAWAIIAN AIRLINES will handle all interaction with the Raffle prize winners for the transfer of the 120,000 HawaiianMiles and any other assistance necessary. The winner is responsible for making their own travel reservations on Hawaiianairlines.com, using the transferred HawaiianMiles as payment. The ground component of the Hawaii trip Prizes will be awarded as a Certificate redeemable for five (5) nights accommodation at the Aston Mahana at Kaanapali. All hotel accommodations are subject to availability and are subject to certain blackout dates. Actual ticket reservations and hotel redemptions are based on space availability and any additional costs (baggage fees, TSA fees, upgrades charges, resort fees, taxes, etc.) are the responsibility of the raffle winner.

**PRIZE AWARDS:** Advance reservations are required to use and redeem all components of the Prizes. The Hawaiian Airlines PRIZE LETTER cannot be replaced by Arizona Aloha Festivals, Inc. or Hawaiian Airlines if lost or stolen. Arizona Aloha Festivals, Inc. reserves the right to substitute prizes of equal or greater value in the event that a particular prize package component is no longer available.

Car rental and/or ground transportation is not included in either prize package.

All Prizes are subject to Award Terms and Conditions shown on the back.

## **AWARD TERMS AND CONDITIONS:**

- Award recipients must be at least eighteen (18) years of age to claim the prize, as required by Arizona State Law. The prize can only be awarded to the person named on the raffle ticket.
- Each air component will be in the form of a Hawaiian Airlines Travel Prize Letter Form ("PRIZE LETTER"), redeemable for 120,000 HawaiianMiles, which is sufficient under current redemption levels to obtain two (2) roundtrip Main Cabin-Coach Class of service tickets from Phoenix to Hawaii. Each PRIZE LETTER will be valid for redemption until at least March 15, 2026 and will be subject to blackout dates and capacity controls. Winners must have or obtain a HawaiianMiles account prior to redemption of the PRIZE LETTER. The PRIZE LETTER will contain the process necessary to redeem the HawaiianMiles. HAWAIIAN AIRLINES will handle all interaction with the Raffle prize winners for the transfer of the 120,000 HawaiianMiles and any other assistance necessary. The winner is responsible for making their own travel reservations on Hawaiianairlines.com, using the transferred HawaiianMiles as payment. The mileage award seats are capacity controlled and may not be available for certain dates and flights. Additional miles may be required if the award level is not available. Additional HawaiianMiles may be purchased at time of redemption or the member may use existing miles from their account. The Administrator is not responsible for any award level changes made by Hawaiian Airlines after March 16, 2025. Due to the ongoing acquisition of Hawaiian Airlines by Alaska Airlines, mileage values and prize award levels may change. In this event, Arizona Aloha Festivals, Inc. reserves the right to substitute prizes of equal or greater value in the event that a particular prize package component is no longer available.
- The ground component of the Hawaii trip Prizes will be awarded as a Certificate redeemable for five (5) nights accommodation at the Aston Mahana at Kaanapali. All hotel accommodations are subject to availability and are subject to certain blackout dates. Actual ticket reservations and hotel redemptions are based on space availability and any additional costs are the responsibility of the raffle winner.
- The Prize winner is responsible for all state and local taxes associated with the redemption of the nights at the Aston Mahana. Additional fees, including baggage fees, food, TSA security fees, etc. are not included.
- Each Prize winner and his/her travel companion is responsible for complying with any and all federal, Hawaii or Maui Covid-19 travel requirements/restrictions. Neither the Festival, Hawaiian Airlines, nor the Aston Mahana will bear any responsibility for the Prize winner's failure to comply.
- Ground transportation and/or car rental IS NOT INCLUDED.

**NOTIFICATION OF WINNERS.** All winners will be notified by the Administrator of the requisite procedure to claim the Prize via telephone or, if unreachable by telephone, by mail. Winners are required to claim their prize within thirty (30) calendar days. The name of the winners will be published on the Festival website at www.azalohafest.org within seven (7) days of the winner's notification. If a selected winner is unable to be contacted or located after a period of thirty (30) calendar days from the Draw date, or does not claim the Prize within the specified time period, the prize will be redrawn from the remaining tickets. This procedure will continue until the prize is awarded.

**WAIVER / LIMITATIONS OF LIABILITY** Ticket purchasers, by participating (and the winner, by accepting the Prize) release Arizona Aloha Festivals, Inc., Hawaiian Airlines, Inc., the City of Tempe, Aston Mahana at Kaanapali, any affiliated agencies and sponsors of the 2025 Arizona Aloha Festival, and any and all officers, directors, elected officials, agents, subcontractors, employees, and volunteers from any and all liability with respect to participation in the promotion, possession, use and distribution of the Prize awarded.

TAXES AND IRS RULES: The winner shall be responsible for any and all federal, state and local income or excise taxes, fees, assessments and like charges associated with the prize. Federal and state withholding laws are subject to change without notice. The withholding laws in effect at the time prizes are claimed will be followed. The IRS has taken the position that amounts paid for chances to participate in raffles, lotteries or similar programs are not gifts and, therefore, the price of the entry does not qualify as a deductible charitable contribution. An IRS Form 1099 will be issued to the winners and supplied to the IRS for tax reporting purposes showing the fair market value of the Prize. The fair market value of each prize package is \$3,895.00.
